INTRODUCTION

The products offered by MARTIGO PLUS comply with the safety standards set out in GPSR Regulation. Always read the instructions and safety information before assembling and using the furniture.

INSTRUCTIONS FOR USE AND WARNINGS

- Furniture is intended for indoor use (air humidity 40-65%, temperature 10-35°C).
- Do not expose the furniture to direct contact with radiators, fireplaces, or sunlight.
- Use the furniture as intended.
- Assemble according to the attached instructions. Any modifications may affect the furniture's safety.

Always check that all parts are sufficiently tightened.

- Do not exceed maximum load limits (e.g., 30 kg for shelves, 50 kg for countertops).
- Do not climb, stand, or sit on the furniture.
- Secure furniture to the wall to avoid tipping over.
- Do not place hot objects on the furniture.
- The surface under the furniture must be hard, level, and stable.
- Do not use the furniture if any damage is detected.
- Ensure a safe environment around the furniture to minimize the risk of entrapment or impact.
- Use only the accessories provided with the furniture for assembly.
- Furniture is not intended for animals.
- Products are not suitable for children under 6 years old.
- Always ensure that furniture within a small child's reach is properly assembled, secured, and anchored - Keep furniture away from fire sources and high temperatures.
- Avoid lifting the furniture by its upper parts or tops to prevent structural damage.
- Do not move or reposition loaded furniture – it may damage the structure or cause tipping.
- In case of broken glass/mirror, discontinue use. Safely remove and dispose of broken parts at a recycling - Regularly check the condition of the electrical installation and bulbs.
- After use, always disconnect the cable from the socket.
- Do not use damaged electrical installations or bulbs.
- Never leave an active installation unattended with children present.
- Tighten bulbs gently to avoid damaging the socket, which could cause a short circuit.

ASSEMBLY

Always check whether all elements listed in the manual are included and undamaged.

If any parts are damaged, contact the manufacturer.

Use only the recommended tools mentioned in the manual and wear protective gloves.

Ensure that all elements are properly tightened and the furniture is stable.

Assembly should be done without the presence of pets or children (risk of swallowing small parts).

MAINTENANCE AND CLEANING

Clean the furniture with a soft, damp cloth.

Do not use aggressive chemical cleaners as they may damage the surface.

Regularly check the condition of the furniture and replace any damaged components.

Ensure that all connections are stable and tightened.

DISPOSAL

After assembly, sort and dispose of packaging appropriately at a recycling point or safely remove. Wooden, metal, and plastic parts should be carefully sorted and delivered to waste collection centers. Do not leave unused furniture in areas accessible to children to prevent accidents.
